As trial counsel for a hospital client, obtained a hung jury in a medical malpractice matter against Emergency Room personnel for alleged failure to diagnose multiple internal injuries following the plaintiff's crush injury between a delivery truck and loading dock (matter later settled by co-defendants without hospital payment).
