### OVERVIEW

Thomas P. Wagner is a litigation and trial lawyer with more than 30 years experience. He also was a board member of the Delaware County Authority from 2001 to 2022, and he served on the Board of Directors for Wheels of Wellness, a non profit organization, from 2001 to 2007.

Tom graduated cum laude from Fairfield University in 1974 with a bachelor's degree in politics. He attended Law School at St. John's University where he was an editor of the Law Review. Following law school, he served a clerkship with the Honorable J. William Ditter, Jr., United States District Judge for the Eastern District of Pennsylvania. He joined the law firm of Rawle & Henderson at the end of his clerkship in 1980 and served for over a decade on Rawle & Henderson's Executive Committee. Tom joined Marshall Dennehey in 2007 as a shareholder in the firm's casualty practice, and he now manages one of the major casualty groups in Philadelphia. He is admitted to practice in Pennsylvania and New York.

## RESULTS

### Successfully Defended SEPTA in a Wrongful Death and Survival Case

#### General Liability

#### Trucking & Transportation Liability

**December 4, 2024**

We successfully defended the Southeastern Pennsylvania Transportation Authority (SEPTA) in a wrongful death and survival case in the Philadelphia County Court of Common Pleas. The case involved the death of a pedestrian, Vincent Boykin, struck by a SEPTA bus, with the plaintiff, his father, disputing the Philadelphia Medical Examiner's suicide ruling. The defense presented a forensic psychiatrist's testimony confirming Mr. Boykin's high suicide risk. Although SEPTA was found 40% negligent, the decedent's 60% negligence barred recovery of damages.

### Defense Verdict for Public Transportation System in Philadelphia's Court of Common Pleas

#### Trucking & Transportation Liability

**December 2, 2024**

We obtained a defense verdict on behalf of a public transportation system in a Wrongful Death and Survival case in the Philadelphia County Court of Common Pleas. The case involved the death of a pedestrian, struck by a bus, with the plaintiff, his father, disputing the Philadelphia Medical Examiner's suicide ruling. The defense presented a forensic psychiatrist's testimony confirming the deceased's high suicide risk. Although the transportation system was found 40% negligent, the decedent's 60% negligence barred recovery of damages.

### Defense Verdict Affirmed in Wrongful Death Case Involving COVID-19

#### General Liability

**September 21, 2023**

We successfully convinced the Pennsylvania Superior Court to affirm the trial court's decision to sustain preliminary objections and dismiss a wrongful death case involving allegation of negligent transmission of COVID-19. The plaintiff alleged that his elderly parents contracted COVID-19 from employees of our client who were providing non-medical, in-home care services, and that his parents ultimately died from the disease.

### Dismissal of wrongful death action against home aide care service.

#### Social Services & Human Services Liability

**November 1, 2022**

We obtained dismissal, with prejudice, of a wrongful death and survival action against a home aide care service. The plaintiff filed an action alleging that employees of our client transmitted COVID-19 to his elderly parents and that, as a result, both of the plaintiff's decedents passed away.

### Plaintiffs' class action certification attempts thwarted.

#### Class Action Litigation

**November 1, 2022**

We received a favorable decision from the Philadelphia County Court of Common Pleas Commerce Program. Our motion to strike the plaintiffs' class action certification was granted, effectively dismissing the plaintiffs' attempts at a class action lawsuit against a transportation authority.

## **SIGNIFICANT REPRESENTATIVE MATTERS**

Successfully obtained a defense verdict for a public transportation system in a Wrongful Death and Survival case in the Philadelphia County Court of Common Pleas. The case involved the death of a pedestrian, struck by a bus, with the plaintiff, his father, disputing the Philadelphia Medical Examiner's suicide ruling. The defense presented a forensic psychiatrist's testimony confirming the deceased's high suicide risk. Although the transportation system was found 40% negligent, the decedent's 60% negligence barred recovery of damages. The claim was further limited by statutory caps applicable to Commonwealth entities.

Successfully obtained summary judgment in an alleged sex abuse case pending in the Eastern District of Pennsylvania. The plaintiff, a minor, alleged that he was abused by an unidentified assailant while at a summer camp in 2002. In granting the motion and dismissing the lawsuit, the judge himself noted that it is rare for the court to enter summary judgment in cases of this nature.

Defense jury award in complex hotel security trial.

Philadelphia Zoo Fire Litigation - Successful representation of target defendant in catastrophic fire loss.
