## RESULTS

Summary judgment in wrongful death, negligent security case involving the shooting of a 16-year-old.

### **Premises & Retail Liability**

**April 22, 2022**

The plaintiff's decedent was shot and killed while allegedly on his way home from school. We were able to prove that the young man was a trespasser on the common area of the property where he was shot, even though his aunt was a tenant in the apartment complex. The decedent's family claimed he was on his way to see her. Our investigation revealed that he was connected to local gangs and that, at the time of his shooting, he was wearing a ski mask (in Florida) and carrying a hand gun.

## **SIGNIFICANT REPRESENTATIVE MATTERS**

Obtained dismissal through Summary Judgment on behalf of a funeral home in a matter involving a claim of mishandling of a decedent's remains and interfering with the rights to a decedent's remains and intentional infliction of emotional distress. We were able to show that the client's conduct in facilitating the burial of the decedent was not willful, wanton, intentional or malicious and that the conduct was not outrageous as a matter of law as required to maintain the claims asserted against the funeral home.

Obtained summary judgment in a negligent procurement of insurance case brought by plaintiffs injured in a motor vehicle accident. Plaintiffs claimed their insurance agent/broker failed to obtain sufficient underinsured/uninsured motorist coverage under an umbrella/excess policy. We demonstrated that the defendants did not breach any applicable standard of care and that plaintiffs could not establish causation regarding the procurement of the policy in place on the date of the accident.

Obtained summary judgment in a wrongful death and negligent security action involving the off premises murder of an employee. The plaintiff's decedent was abducted, stabbed, and strangled during her lunch break after leaving the workplace parking lot with a man who had been looking for one of her co workers. We demonstrated that the crime was not foreseeable and that the client owed no duty. The First District Court of Appeal affirmed the order granting summary judgment.
