## **SIGNIFICANT REPRESENTATIVE MATTERS**

Successfully defended a trampoline park in a personal injury action brought by a 17-year-old plaintiff who alleged she sustained a torn ACL during gymnastics training. The defense focused on the scope of duty owed by trampoline parks under Connecticut law and the enforceability of participant waivers. The matter also involved challenging the plaintiff's claimed status as a "future Olympic figure skater," including extensive discovery and deposition regarding her athletic background.

Defended roller skating facilities in multiple premises liability actions arising from patron fall-down incidents. Each case centered on the facilities' duties to patrons and was resolved through nuisance-value settlements.

Represented a municipality in a recreational injury case in which the plaintiff fractured his leg sliding into third base. Successfully obtained summary judgment, with the court finding the municipality owed no duty under the circumstances.

Defended hockey rink operators in claims arising from player altercations during games, alleging failure to intervene. Each case was resolved favorably with nuisance-value settlements.
